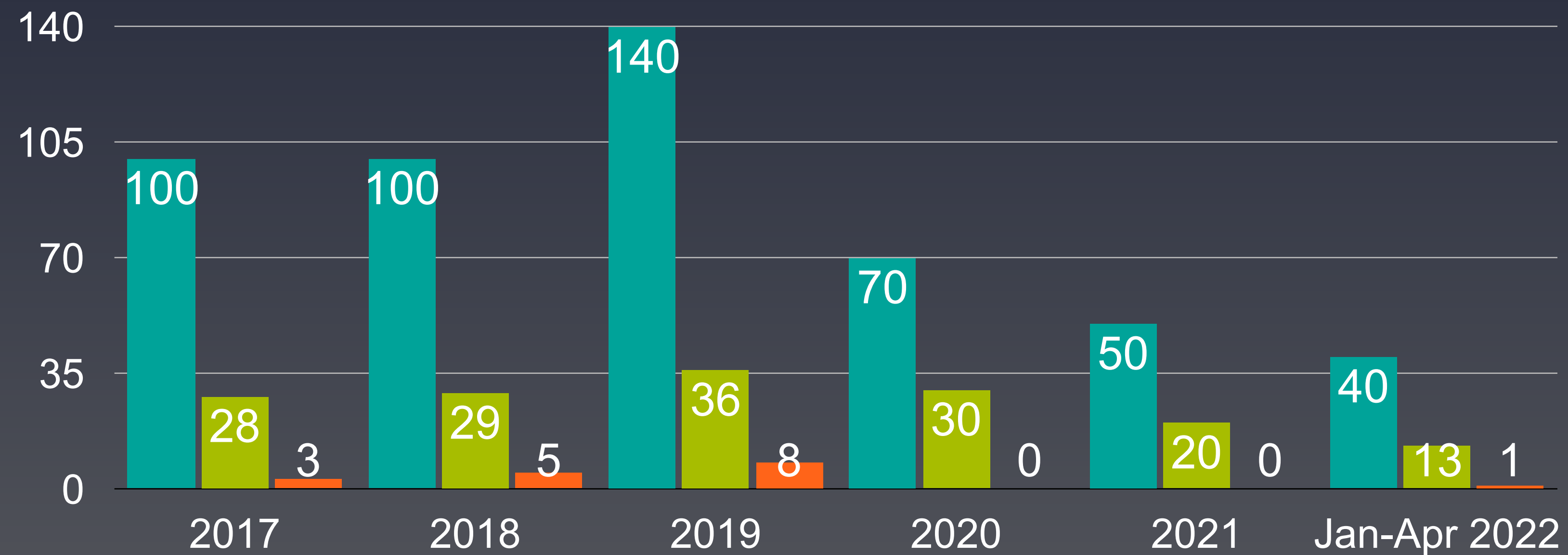

- ARIN-2020-6: Allowance for IPv4 Allocation “Swap” Transactions via 8.3 Specified Transfers and 8.4 Inter-RIR Transfers

- AFPUB-2019-GEN-006-DRAFT03: RPKI ROAs for Unallocated and Unassigned AFRINIC Address Space – **Ratified - Awaiting Implementation**

LACNIC

- LAC-2020-10: Authorize Recipients of Delegated Blocks to Sign ROAs, that would allow the holders of sub-allocations and sub-assignments to create ROAs

Under Discussion: Leasing



ARIN

- ARIN-2021-6: Permit IPv4 Leased Addresses for Purposes of Determining Utilization for Future Allocations
- ARIN-prop-308: Leasing not Intended

LACNIC

- LAC-2022-2: Clarification: Resource rental is not accepted in current policies
